

1. The **17th INTERNATIONAL MEETING OF L'HOSPITALET PARA ATHLETICS** will be held on May 28, 2022 (morning) in the following location: Complex Esportiu L'Hospitalet Nord.
2. This competition is included in the WPA (World Para Athletics) calendar and its results are recognized by this organization for the purposes of rankings and records.
3. This competition is regulated by the [World Para Athletics Rules and Regulations](#), unless otherwise stipulated in these regulations.
4. The competition is open to both national and international athletes with prior invitation.
5. All athletes interested in participating must apply online by sending the [registration application form](#) before April 25. The Organization will assess each case based on the track record of the athletes and will send an answer within 15 days to confirm the registration.
6. The **winner of each event** both in male and female category will receive an economic prize of 100€. Financial prize will be awarded in the events with a minimum participation of 4 athletes only. The delivery of this economic prize will take place at the end of the Meeting, in the position located for that purpose.
7. The Organization establishes a special prize of €500 for athletes who manage to break the **world record** of their class during the competition.
8. The **first three classified in the competition** in accordance with the points system final classification for all events in male and female categories will receive a trophy.
9. Finals results will be weighted in accordance with the WPA points system. In the field events athletes will grant additional attempts base on the score points.
10. Athletes participating in the out-of-competition events or with less than 3 participants will not receive the economic prize.
11. Athletes participating in any event without any proven disability will not receive the economic prize.
12. The Organization will provide accommodation on a half board basis to national (one night) and international (two nights) participants who reside more than 150km away from the city of L'Hospitalet del Llobregat (Barcelona), who have been invited by the Organization.
13. The Organization will award a travel scholarship **exclusively** to national and international athletes who have obtained a medal in the last Paralympic Games, World Championship or European Championship and who reside more than 150km away from the city of L'Hospitalet del Llobregat (Barcelona). The type of award and the economic value of the scholarships must be agreed by each athlete with the Organization before sending their registration application form.
14. Without prejudice to the above conditions, the Organization may agree different conditions with any athlete according to their judgment.
15. The Organization will not be responsible for any travel, lodging or maintenance expenses that have not been agreed with the athlete prior to the Meeting.
16. All participating athletes must have the valid federation license and/or the corresponding WPA license.
17. The final schedule of the events and the starting lists will be published on the web <http://www.hospitaletparaathletics.cat/> at least one day prior to the celebration of the event.

18. For organizational reasons, the Organization reserves the right to modify the schedules of the events as well as the starting lists. Any modification will be notified to all the athletes in advance.
19. Athletes may request changes in their participation in the different contest and races. The Organization will resolve all requests according to their judgment. Under no circumstances will changes be accepted on the same day of the competition.
20. The Organization will allow the participation of athletes without proven disabilities in any of the events, according to their judgment. Athletes without any proven disability will not receive any type of prize.
21. All athletes have to participate with the number delivered by the Organization, correctly placed and clearly visible. The delivery of the numbers will be made prior to the start of the event, the same day of the competition, in the position enabled by the Organization for this purpose.
22. All athletes must stop by the **Call Room** before the scheduled meet time of the respective event. Call Room opens 20 minutes before the scheduled time for track events and 30 minutes before the scheduled time for field event.
23. Once their participation is over, all athletes must leave the track immediately and remain in the grandstand area, in order to facilitate the task of the Organization and avoid disturbing the rest of the participants.
24. The timing of the races will be carried out by judges and timekeepers of the Catalan Athletics Federation.
25. The results will be published as the competition goes by and will be available later on the Meeting website <http://www.hospitaletparaathletics.cat/>
26. The athletes who are required to go through the anti-dopping control should attend the anti-dopping medical unit established by the Organization and follow their instructions.
27. All participants are covered by the Civil Liability Insurance. The Organization declines all responsibility for damages, harm or injuries that the participants may suffer themselves or cause to others during the developing of the competition.
28. The participants will be responsible for the care and custody of their personal items. The Organization is not responsible for the damage or loss of any personal belonging of the participants or their companions.
29. All athletes explicitly allow their name, surnames, gender, year of birth and other relevant information to appear on the public lists of registered participants, as well as in the results once the competition has concluded, following the established regulations.
30. All athletes authorize the Organization to use the photographs and other media content taken during the day of the competition in order to promote the Meeting.
31. Athletes may claim to the Organization any circumstance they consider appropriate. Claims will be written to the [Pere Suñé Foundation of L'Hospitalet Atletisme](#), and will be resolved according to the established procedure. The decision made by the Pere Suñé Foundation will be unappealable.
32. The Organization will have the power to resolve any incident that is not planned in advance. The Organization reserves the right to modify any aspect of the Meeting, if the circumstances require so.
33. In case of contradiction between these rules and the WPA Regulations, what will prevail are these rules.

34. The registration and participation in this Meeting imply the acceptance of the previous rules.
35. **COVID-19 Disclaimer Statement:** All athletes, team members and companions participating in the Meeting are fully responsible to comply with rules and regulations required by the authorities by their own means. In particular, international attendants will be responsible to take the Covid-19 test/ check should it be required by their own country and/or Spanish authorities when entering or exiting the country.

Under no circumstances the Organization will be held responsible or liable in any way for any claims or damages resulting from attendants failing to comply with those rules and regulations.
